Notices & Agreements:

Participants must be onsite, in full garb and ready to perform by 9:30 AM on Saturday for Participant Morning Meeting and 10:00 AM on Sunday for Participant Photo. All participants must be available to perform rain or shine from 9:45 AM until 8:00 PM on Saturday and 10:45AM until 6:00 PM on Sunday; unless prior arrangements have been made with Festival Management. All participants must be at Front Gate for Opening Gate Ceremonies/Scenario.

Rules & Policies:

- Participants must appear throughout entirety of contract days in full garb; shoes are mandatory for all participants, street and stage. It is the responsibility of each contracted participant to provide his/her own garb and accessories necessary to perform contracted job.
- All participants must be on time and perform as scheduled in the program unless otherwise specified by Festival Owners/Management.
- All Weapons must be sheathed and peace bound at all times, with the exception of those performers/troupes that use weapons as part of their show. It is expected that at the end of said shows, all weapons will either be peace bound or locked in restricted access trunk.
- There is a **strict zero tolerance** for the consumption of alcohol, the use and/or distribution on any part faire site, including the parking lot, at any time during hours of operation. Violators will be turned over to the proper authorities for prosecution, all contract monies will be forfeited, and offenders will be permanently banned from all future involvement in any Festival or Event owned, operated, or managed by Williams Entertainment.

- Participants must abide by all rules and policies of Williams Entertainment. These rules and policies are incorporated herein and become part of this agreement between the participant(s) and the Festival.
- This contract is terminable at will by Williams Entertainment for violations of these rules and policies. Any violation of these rules and policies will result in forfeiture of all contract monies agreed to.

Special Provisions:

- Payment will be made at the close of Festival on Sunday, if possible. If not possible, payment will be made within ten (10) business days after close of Festival.
- If for any reason the Festival does not open on any scheduled day, the contract price shall be adjusted on a pro-rated basis. If for any reason a participant does not perform at an agreed upon time and place, the contract shall be adjusted on a pro-rated basis.
- The participant(s) agrees to allow Williams Entertainment and its associates to use photos, videos, and performer's individual likeness for advertising purposes.
- The undersigned agrees to indemnify GLRF, Williams Entertainment, its owners and managers; and hold the aforementioned parties harmless from any liability or claim; including but not limited to bodily injury, property damage, fire, theft, explosion, or any loss sustained by the undersigned or any of the undersigned's group while contracted with Williams Entertainment.
- It is agreed that the above contractor is an independent contractor and as such the contractor is responsible for all and any taxes, including workman's compensation insurance.
- This contract is a confidential agreement with said participant(s); neither the contracted participant(s) nor Management of Williams Entertainment shall disclose any of its compensatory details to any other party.
